- 4. WAIVER OF COMPENSATION: NO COMPENSATION, ROYALTIES, OR PAYMENTS** will be made to me or my child for the use of my child's image, for any non-profit educational purposes, or for future use of materials.
- 5. RELEASE FROM LIABILITY: I RELEASE AND HOLD HARMLESS** Jah Kente International from all claims, damages, or liability from my child's participation or use of materials.
- 6. WAIVER OF RIGHTS:** I waive all moral rights, privacy rights, publicity rights, and right to inspect or approve the finished product.
- 7. PERPETUAL GRANT:** This release is **IRREVOCABLE** and grants Organization rights **FOREVER**

worldwide. Rights may be assigned to third parties.

8. WARRANTIES: I am the parent/guardian with full authority to sign this agreement. No other consent is required.

9. INDEMNIFICATION: I agree to protect the Organization from any claims or expenses arising from this agreement or my child's participation.

10. GOVERNING LAW: This agreement is governed by the laws of Washington, DC
